FOLLOW THESE STEPS TO ENSURE YOUR CREDITS ARE PROCESSED ON TIME

- 1. At the completion of each course, make sure to receive the Certificate of Attendance & Evaluation Form from the course instructor. This form is a triplicate copy, with an Evaluation Form located on the back of the white copy. The Evaluation Form is MANDATORY to receive credit for the course. If the Certificate of Attendance Form is submitted without a completed evaluation, we will not process your credits. *** Your feedback is important so the administrator can offer recommended courses for contractors in the future. ***
- 2. Mail in your completed Certificate of Attendance & Evaluation Form and payment to FWWA, 325 John Knox Road Suite L-103 Tallahassee, FL 32303. Checks must be made out to FWWA.
- 3. Once all 12 credits and payment have been submitted for that renewal cycle, you will receive a Certificate of Completion. Keep this in your records as proof of completion.
- 4. The FWWA Office does not handle renewing of your Contractor's License. To complete this process you will need to contact your Water Management District directly.

QUESTION OF THE DAY

Q: Will the FWWA approve a course I took from a non FWWA course provider or in another state?

A: It is possible, but not guaranteed. Obtaining Continuing Education Credits (CECs) from non - providers, or from other states is possible if you are proactive. It is a good practice, before you spend the time and the money to attend a course or continuing education event, gather the information on the course(s) and send to Danielle Jessup, Water Well Administrator to be reviewed. There is a strict criterion that the course must contain, and therefore the following information must be submitted for review:

- 1. An agenda with the time schedule of the CEC course/session(s).
- 2. A description that contains the content of each course/session. A course title is not sufficient information. The curriculum of the course MUST be water well related and cannot be specific to a state other than Florida.
- 3. A bio or resume of the course instructor for each session.
- 4. All non FWWA courses will be reviewed by the Florida Water Well Administrator. Approval/denial will be based on the above mandatory criteria submitted by the licensee. It is the responsibility of the licensee to send the required materials to the FWWA in ordered to be reviewed.

***IMPORTANT NOTE:** Chapter 62-531, Florida Administrative Code, defines a CEC as one (1) hour (a minimum of 50 minutes) of approved coursework or instruction.

THE 2013-2015 RENEWAL CYCLE IS IN FULL SWING

Don't wait until the last minute to obtain the required 12 CECs needed to renew your license. Licensees must have a total of 12 CECs, with a minimum of 6 CECs in rules/well construction practices and a maximum of 3 online CECs by July 31, 2015 for license renewal.
